## **ROAD DEPARTMENT REPORT:**

Tree Trimming Contract – A motion was made by Mr. Saunders to ratify the tree trimming contract that has been awarded to Borty's Tree Service in the amount of \$15,600.00 and to close Stanford Road during tree trimming scheduled removal times, as well as to notify the residents in writing of the tree trimming. All in favor. Motion carried. Mr. Saunders made an additional motion that any additional work that may be necessary to add to this contract would not exceed \$20,000.00. This was seconded by Mr. Jesteadt. All in favor. Motion carried.

Aggregate Quotes: A motion was made by Mr. Saunders to purchase #2A Limestone, #3 Limestone, #8 Limestone, Limestone Sand, #57 Limestone, R-4 Rip Rap, R-6 Rip Rap, and R-7 Rip Rap from McClymonds Supply and Transit and to purchase R-5 Rip-Rap and Anit-skid 3B from Dale McClymonds. This was seconded by Mr. Jesteadt. All in favor. Motion carried.

#### **UNFINISHED BUSINESS:**

ARPA Funds – Mr. Saunders made a motion to return the funds transferred as "lost revenue" back to the Corona Virus Fiscal Relief Fund, as the board has chosen to take the "standard allowance of up to \$10 million in lost revenue" for the use of the ARPA Funds. These funds will be transferred into the General Fund as they are used for various qualifying projects. This motion was seconded by Mr. Jesteadt. All in favor. Motion carried.

Tire Letter – A motion was made by Mr. Saunders and seconded by Mr. Jesteadt to send a letter to both the property owner and the tenant, giving them 30 days to remove the tires from the property. DEP will also be notified of this issue. All in favor. Motion carried.

Grubbs – Hardship Exemption – Mr. Robert Grubbs asked that he be able to disconnect one of his trailers from all septic and utilities and be allowed to keep it as a storage unit until he is able to build a home on the property. Mr. Saunders stated that Mr. Grubbs would be permitted to keep this trailer as a storage unit for up to one year, under the condition that it be disconnected from all septic and utilities as soon as possible. This will be verified by the SEO, who is to instruct Mr. Grubbs as to how the septic system is to be disconnected.

## **NEW BUSINESS:**

Updating Junk Auto Ordinances – Mr. Saunders made a motion to forgo looking into updating these ordinances, as the updated Junk Yard Ordinance that the Board had been working on will take care of many of the same issues. Mr. Jesteadt seconded this motion. All in favor. Motion carried. Mr. Saunders also made a motion to table further discussion regarding the updated Junk Yard Ordinance until the other members of the board were able to become more familiar with the document. This was seconded by Mr. Jesteadt. All in favor. Motion carried.

Mr. Saunders made a motion to add "Crack Sealing" to the agenda. This item was not previously on the agenda because project information was not available until the meeting was already in progress. This motion was seconded by Mr. Jesteadt. All in favor. Motion carried.

Mr. Saunders made a motion allowing the Road Crew to accept a bid for crack sealing for no more than \$11,000.00 outside of a board meeting, with the approval of the Road Master. Mr. Jesteadt seconded this motion. All in favor. Motion carried.
