TREASURER'S REPORT:

A motion was made by Mr. Saunders to accept the treasurer's report for the month of November, 2018. Second by Mr. Kerr. All in favor. Motion carried.

Kerry/Santa: Lot Line Revision

- 1. Waiver: Secondary Septic Testing A motion was made by Mr. Saunders and seconded by Mr. Kerr to approve the waiver request for alternate septic testing. All in favor. Motion carried.
- 2. Waiver: 2 foot contours A motion was made by Mr. Saunders and seconded by Mr. Kerr to approve the waiver of the 2 foot contour requirement. All in favor Motion carried.
- 3. A motion was made by Mr. Saunders and seconded by Mr. Kerr to approve the Kerry/Santa Lot Line Revision. All in favor. Motion carried.

EMERGENCY SERVICES: No Update. .

ROAD DEPARTMENT REPORT:

- Generator: The generator was purchased for the traffic signals
- Private Lane Signs: Contact the property owners on the lane about the installation of signs and the township will cover the costs for the initial installation but the property owners on the private lane will be responsible for replacement of the signs. All future developments will be required to install and maintain signage.
- Intersection Street Lights: The street lights have been replaced/repaired at Pilot and I/79 North.

PERMITS ISSUED:

<u>SWM:</u> Dollar General: Additional dye testing is scheduled to be completed with a tentative date of December 27, 2018.

<u>Septic:</u> A motion was made by Mr. Kerr and seconded by Mr. Saunders to approve the Annual Granny Plat applications for Pinkerton (PinkertonTrail/Stanford Road), and Eisler (Yellow Creek). All in favor Motion carried.

UNFINISHED BUSINESS:

Tax Credit Ordinance: Mr. Saunders and Mrs. Livermore met with VFD and EMS to discuss the proposed ordinance. A request for additional information was requested from both organizations to assist in determining eligibility for the tax credit.

Resolution 2018-07 - 2019 Budget: A motion was made by Mr. Saunders and seconded by Mr. Kerr to approve the 2019 budget. All in favor. Motion carried.

Traffic Signals (I 79S/422): Penndot contacted the township to report that the traffic signals have been installed and turned over to the township 12/15/18. The Pilot lights still have a relay switch that needs installed. Once the relay switch has been installed, the 30 day test period will begin.

NEW BUSINESS:

Sunset Ridge Road: The solicitor and engineer are working on the plan/agreement.

Building Maintenance Bonds: A motion to release the K and K Mechanical, Newman Plumbing, McCurley Houston Electric and Swede Construction bonds was made by Mr. Kerr and seconded by Mr. Saunders. All in favor. Motion carried.

Insurance Premium Renewal: A motion was made by Mr. Saunders and seconded by Mr. Kerr to approve the renewal of the insurance premium for 2019. All in favor. Motion carried.

Guiderail Bid: A motion to approve bidding the guiderails was made by Mr. Saunders and seconded by Mr. Kerr. All in favor. Motion carried.

PEMS Restricted Donation: A motion was made by Mr. Saunders and seconded by Mr. Kerr to authorize PEMS to use the township's donation for operational/equipment needs in addition to personnel costs.
