Motion carried.

<u>HULVER/SHAFFER</u>: Mr. Hulver presented his lot line plan. Mr. Hulver requested a waiver of the 2 foot contours. Mr. Hulver requested a waiver of the alternate septic test site for each parcel. The Muddy Creek Township Planning Commission recommended approval of the plan. A motion was made by Mr. Saunders to approval the waiver of the 2 foot contours and alternate septic test site for each parcel and approval of the plan. Second by Mr. Jesteadt. All in favor. Motion carried.

<u>DESUTA LAND DEVELOPMENT</u>: Mr. Desuta requested approval from the Board o install a holding tank. Mr. Duncan performed testing on the parcel. The parcel did not perk anywhere. A motion was made by Mr. Saunders to install a holding tank in accordance with township ordinance 64. Second by Mr. Jesteadt. All in favor. Motion carried. A motion to approve the preliminary land development plan presented by Dave DeSuta with the recommendations of the Muddy Creek Planning Commission was made by Mr. Saunders and seconded by Mr. Jesteadt. All in favor. Motion carried.

# ROAD DEPARTMENT REPORT:

- A. Red Truck: Bid was awarded to the 2<sup>nd</sup> highest bidder for \$12,400. A resolution is needed to budget the funds.
- B. <u>Bauder Mill Bridge Guiderails:</u> Mrs. Livermore will check with the road department to inquire if they are able to install guiderails. If not, then quotes should be obtained. A motion was made by Mr. Saunders that if quotes were received between meetings and two supervisors agreed, the guiderails can be installed. Second by Mr. Jesteadt. All in favor. Motion carried.

- C. <u>Bauder Mill Stormwater:</u> Project completed.
- D. <u>Logging Over Posted Weight Permit:</u> A motion was made by Saunders and seconded by Mr. Jesteadt to release the Mitchelltree Brothers bond. All in favor. Motion carried.
- E. <u>Crack seal Badger Hill Road:</u> A motion was made by Mr. Saunders to crack seal the end of driveway where the township truck turns around at 190 Badger Hill Road and authorize the road department to request permission from the Commonwealth to construct a turnaround on state property on Badger Hill Road. Second by Mr. Jesteadt. All in favor. Motion carried.

Mrs. Vivian Caruso was present to provide the 2012 audit report for the Muddy Creek Township funds. A motion to accept the audit report was made by Mr. Saunders. Second by Mr. Jesteadt. All in favor. Motion carried.

- E. <u>Sewage Temporary Holding Tank Agreement</u>: Motion by Mr. Saunders to adopt the agreement to be used for temporary holding tanks in accordance with Ordinance 64 in Muddy Creek Township. Second by Mr. Jesteadt. All in favor. \
- F. <u>Letter to Sheriff Slupe</u>: Signed by the Board.

- A. <u>Department of Auditor General</u>: An auditor was on site on Monday, September 16, 2013 to review the liquid fuels account for 2012. One note was that the craftco rental should be recoded. The review was positive.

A motion was made by Mr. Saunders to authorize Mr. Smith to send a letter to the property owner referencing the ordinance violation. Second by Mr. Jesteadt. All in favor. Motion carried.
