### **COMMITTEE UPDATES:**

### <u>Planning Commission</u>:

Organizational Meeting held on January 3, 2012 at 7:30 PM: Sean Gramz voted as Chair, Don Hutchins voted as Vice Chair, and Jim Jancse as Secretary.

The Commission voted to request payment of \$50/member in attendance at the meetings. This includes the seated alternates. The Board of Supervisors has not budgeted for payment of commission members to attend monthly meetings.

The Commission voted to request that the Township Secretary file all final plans at the courthouse and not rely on the applicant to file the plans. Mr. Saunders motioned to approve for the secretary to record final plans. The cost associated for the filing will be coded to the applicant's subdivision/land development fee. Second by Mr. Kerr. All in favor. Motion carried.

Trettel/Cravener: No one present to address with the Board.

Annual Report: Mrs. Livermore presented a copy of the annual report of the planning commission for 2011.

#### **BCATO**:

Mrs. Livermore reported that the committee is working on the spring conference. Mrs. Livermore continues to serve on the Tourism committee of the association.

#### COG:

Mr. Jesteadt attended the first meeting of the year. Mr. Jesteadt reported that there are opportunities for cost sharing with other townships. Mr. Furman from DCED was present at the COG meeting and informed the group that there is \$500,000 for approved projects. Mr. Jesteadt will check with Connoquennessing Township to inquire about future road projects and the joint bidding of asphalt. Mr. Kerr will check with Lancaster Township.

#### **ROAD DEPARTMENT REPORT:**

- A. <u>Borough Roads</u>: It is estimated that the resurfacing of the boroughs portion of Stanford Road will cost an estimated \$8,000. Mr. Kerr will be attending the next meeting. The township will continue to invoice the borough of winter maintenance.
- B. Protech Asphalt: No report has been submitted.

- C. 422 Auction: 422 Auction had pipes checked on Currie Road. Mrs. Livermore will request a meeting with the county bridge engineer to get the plans for the replacement of the bridge on Currie Road.
- <u>D. Generator Hookup</u>: Motion to approve for the road department to have an electrician install a connection for a generator at the road department building at an estimate cost of \$500.00 made by Mr. Saunders. Second by Mr. Jesteadt. Payment to be made from the building fund. All in favor. Motion carried.

- B. <u>National Flood Insurance Ordinance</u>. Motion to table made by Mr. Saunders. Second by Mr. Kerr. All in favor. Motion carried.
- C. <u>Hardship Hookups</u>: Mrs. Parson called and said that she was not able to get the paperwork to the office. Mr. Ron Parson called and said that he would have the paperwork dropped off on Thursday, January 19. Motion made by Mr. Kerr to deem Mrs. Parson in violation if the complete application and agreement are not submitted Thursday, January 19<sup>th</sup>. Second by Mr. Saunders. All in favor. Motion carried.
- D. <u>Sewage Ordinance</u>: Motion to remove from the agenda by Mr. Saunders. Second by Mr. Jesteadt. All in favor. Motion carried.
- E. <u>Township Building</u>: A certified letter was sent to Mr. Sperdute to obtain all documents relative to the township. No response was received from Mr. Sperdute. Motion to table made by Mr. Kerr. Second by Mr. Saunders. All in favor. Motion carried.
- F. <u>Hufnagel (Adams) Driveway Permit</u>: Mr. Rock called and claimed that he repaired his driveway. Mr. Artzburger called and said that he does not have a driveway in violation and that what the township believes is a driveway is actually a path for quads. No response from Adams. Mr. Kerr will investigate the Artzburger driveway. Mr. Flinner or Mr. Hempfling should investigate the Rock driveway.

#### **NEW BUSINESS:**

- A. <u>Redistricting</u>: Notification of the proposed redistricting still awaiting passage by the legislature. Muddy Creek would move to Elder A Vogel, Jr. district and remain in Richard Stevenson's district.
- B. <u>Cheeseman Parcel</u>: The parcel the well pad is located is part of the Agricultural Securities Program. Mrs. Livermore will send a letter to instruct the property owner to request that the portion that is consumed by the well be removed from the program.
- C. <u>Bear Run Campground</u>: Mr. Wehr has requested for No Outlet signage to be installed on Badger Hill Road and he is willing to cover the costs of the sign. Mr. Saunders has requested that two signs be installed and the anti theft screws be used. Motion made by Mr. Saunders for the sign installation on Badger Hill Road. Second by Mr. Kerr. Motion carried.
- D. <u>Tenant Registration</u>: Mrs. Livermore will be sending letters out for tenant registration to be distributed the beginning of February and due April 1, 2012. Mrs. Livermore stated that the ordinance requires that the tenant submit their social security numbers. Mr. Saunders and Mr. Kerr approved for the removal of the social security information from the forms.
- E. <u>Auditor Position</u>: Mr. Hart was appointed in the beginning of the meeting.
