**SWM:**

203 Levis Road (Hvizdak): requesting a waiver for submitting a stormwater plan. Tom Thompson recommended approval for the waiver. A motion to approve the waiver of the SWM plan as per Ordinance 65, Section 302.E with the condition that the property owner will maintain the pipes that drain to the culvert and the engineer will perform a final inspection of the driveway upon completion of the paving.
