COMMITTEE UPDATES:

- Planning Commission:
 - Oliver Plan: Ms. Oliver presented her final lot line revision plan to the Board. Mrs. Oliver is requesting a waiver on the 2 foot contours, alternate septic testing and building setback. (1). A motion was made by Mr. Saunders to approve the waiver of the 2 foot contours. Second by Mr. Jesteadt, All in favor. Motion carried. (2). A motion was made by Mr. Saunders to approve the waiver of the alternate septic testing. Second by Mr. Jesteadt, All in favor. Motion carried. (3). A motion was made by Mr. Saunders to approve the building setback from 75 feet to 45 feet only for the installation of the mobile home. The motion was seconded by Mr. Jesteadt. All in favor. Motion carried. (4). A motion to approve the Oliver Lot Line Plan with the authorization for Mr. Kerr to sign the plan outside the meeting was made by Mr. Saunders and seconded by Mr. Jesteadt. All in favor. Motion carried. (5). A motion to approve the Jones Excavating estimate for the materials and installation of the small flow in the amount of \$14,000 was made by Mr. Saunders and seconded by Mr. Jesteadt. All in favor. Motion carried.
 - Hiteshew (Perry Highway): Presented the Board with a stormwater request for a drainage pipe extension onto a current pipe that crosses under Route 19. Mr. Hiteshew will contact PennDot to determine if the end of the pipe is in the PennDot right of way. Engineer Tom Thompson will look at the location as well.
 - <u>Desuta Plan:</u> Mr. Dan Moore presented to the Board his concerns with the right of way which crosses Mr. DeSuta's property.

ROAD DEPARTMENT REPORT:

- A. Wallace Road (Gearhart) Driveway. Drainage work not complete.
- B. Freightliner: Chipped windshield from vehicle on I-79.
- C. Water from Property onto Roads: The Road Foreman requested correspondence is sent to the following property owners regarding water onto roadways: 303 Stanford, 287 Bauder Mill Road. Mr. Saunders stated that there is an issue on Yellow Creek Road as well.
- D. <u>Dirt and Gravel Road Maintenance Program</u>: In order to qualify for funding, the township has to have an ESM certification. The training is no cost. Mrs. Livermore will discuss the upcoming workshops with the Road Foreman to schedule attendance at the training.
- E. <u>Sign Management</u>: The Township is required to have a sign maintenance management or assessment program in place by June 13, 2014.

- A. <u>PSATS Conference</u>: Need to let Mrs. Livermore know if any officials are attending this year's conference.
- B. <u>Hufnagel Address Sequence</u>: A notice has been sent to the property owners on Hufnagel Road to correct the address sequencing.

NEW BUSINESS:

- A. Act 205: Nonuniformed Pension Plan submission to the Commonwealth
- B. <u>2013 Pension Aid</u>: The Township received an excess amount since the road worker was not eligible until his anniversary date. The excess can be maintained until the audit
- C. <u>Abstaining from Votes</u>: According to the State Ethics Commission, if a supervisor must abstain from a vote due to a conflict of interest, the supervisor must announce the nature of the conflict at the meeting and file a written memorandum with the township secretary who notes it in the minutes....Just an FYI.

- D. <u>PEMA</u>: PEMA is conducting a Spring Hazardous Weather Emergency Preparedness Exercise on May 12 and 13 in conjunction with the National Guard's "Vigilant Guard" exercise. PSATS encourages townships to participate.
- E. <u>Hauling Permits</u>: Oversized hauling is now permitted 7 days a week. As part of the transportation funding bill, this addition of 2 days for oversized hauling was enacted. PennDot is now requiring that permits for special events such as parades etc. have to be made through them to avoid hauling conflict.
- F. <u>Local 66 Pension Contribution</u>: The township's contribution increased from 2.01 to 2.09.
- G. <u>Portersville EMS</u>: Mr. Shreffler has requested on behalf of the Portersville EMS for funding of the EMT position. Mrs. Livermore will contact Mr. Shreffler and inform him that a formal request needs to be submitted along with the last two years budgets and the last two audits.
