TREASURER'S REPORT: Mrs. Livermore provided copies of the treasurer's report for the month ending April, 2010 Motion to accept the report made by Mr. Kerr, second by Mr. Gramz. All in favor. Motion carried.

- A. <u>Planning</u>: The Commission met on April 22. A review of the Deb Allen Land Development application was discussed. Mrs. Allen did submit a land development application and will be reviewed this month.

- C. <u>Butler County Council of Governments</u>: Introduction of the Power of 32 initiatives was provided at the last meeting.

Mrs. Livermore provided an update on the loop sensor and the condition of the Pilot roadway and repair. Tom Thompson is reviewing the traffic signal plans to determine the timing on the lights exiting Pilot. If Pilot wants them changed, then they have to make the request in writing so that they cover any costs incurred to make the change.
- D. <u>Appraisal of Township Property</u>: Mrs. Livermore contacted Jim Keffalas to do an appraisal of the property. He quoted a cost of \$450. Motion made by Mr. Kerr to approve Keffalas to complete the appraisal at \$450. Second by Mr. Grams. Motion carried.

- E. Section 9006 of the Health Care Bill: Mandates 2010 all companies will have to issue 1099 tax forms to all individual or corporations which they buy more than \$600 in goods or services in a tax year.

SECRETARY'S COMMENTS: Mrs. Livermore has been working on a grant from the USDA to requests funds to assist with the purchase of a backhoe. According to the USDA, the township would be eligible for 35% assistance for the purchase. Mrs. Livermore will continue to work on the grant to submit prior to the next meeting.
