**ROAD DEPARTMENT REPORT:**

Crack sealing Agreement: A motion was made by Mr. Saunders and seconded by Mr. Jesteadt to approve the agreement with Suit Kote in the amount of \$14.25/gallon. Roads scheduled to be completed include Fisher, Johnson, Burnside and Cheeseman). All in favor. Motion carried.

Merriman Plan: Mr. Miller is subdividing a parcel. In accordance with the SALDO, Merriman Lane should be brought to current road construction standards from

Road Foreman Wages and Pension Contribution: A motion was made by Mr. Saunders and seconded by Mr. Jesteadt, pending a memorandum of understanding with IUOE Local 66, to increase the Road Foreman wage to \$32.00/hour with a three-year wage freeze (2021-22-23). If the position is vacated, the wage will be re-evaluated. Pay will begin with the first pay period in April, 2020. An increase of .80/ hour worked contribution to the Central Pension Fund for eligible members beginning with the first pay period in April, 2020. All in favor. Motion carried.

Private Lane Signage Agreement: A motion was made by Mr. Saunders and seconded by Mr. Jesteadt to approve the private lane signage agreement. All in favor. Motion carried.

Overposted Weight Permit: A motion was made by Mr. Saunders and seconded by Mr. Jesteadt to contact the owner of the truck company on Burnside regarding the overposted weight permit requirement. All in favor. Motion carried.
