<u>PSATS Legislative News Update</u>: State Fine Money: Municipalities that have a population of 3000 or less or provide at least 40 hours per week of police service may continue to receive revenue from state police fines. Act 87 of 2012 lengthens the time period for approvals under the permit extension act for an additional three years until July 2, 2012. It also imposes a gas drilling moratorium in portions of Bucks and Montgomery County. Natural gas storage fields are reaching their capacity. Land Use modification to the MPC requiring the township to provide a monthly report to the school district superintendent if they approved a plan for residential development during the preceding month.
