ROAD DEPARTMENT REPORT:

Road Work/Bids for 2018: A motion to approve bids for Paving, Road Oil and Aggregate made by Mr. Saunders and seconded by Mr. Jesteadt. All in favor. Motion carried.

Guiderails: A motion to approve the agreement for the guiderails pending verification of Costars member and updated quote made by Mr. Kerr and seconded by Mr. Saunders. All in favor. Motion carried.

Complaint: Mud on the road from Sloan Lane and on Bauder Mill Road.

Water Drainage: The road department has been cleaning up and salting roadways where water is draining onto the roadways. Letters send to property owners.

Tree Trimming Agreement: (Oak Grove and Wallace Roads) Two quotes were received. Borty's Tree Service and Stephenson. Stephenson has not experience doing a project this size. Stephenson could not provide references that could verify work performed on a project the size that the township is quoting. The job needs completed by the end of March, weather permitting. Bortys has experience in performing the tree removal service on a project the size being quoted, they will complete the project by the end of March, weather permitting. A motion to approve Bortys Tree Service in the amount of \$19,000 was made by Mr. Saunders and seconded by Mr. Jesteadt. All in favor. Motion carried.

2018/19 Costars Salt: A motion was made by Mr. Kerr and seconded by Mr. Saunders to place an order for 400 Tons of salt through the Co-Stars bidding process for the 18/19 Winter Season. All in favor. Motion carried.

Traffic Signal: Mr. Saunders inquired if Penndot responded to the request to place the traffic signals on 422/I79 on blinker mode from 10 PM – 6 AM. There has been no follow up.
