BOARD OF SUPERVISORS**

CALL TO ORDER: The Muddy Creek Township Board of Supervisors was called to order at 7:01 PM by Mr. Dale Kerr. Pledge of Allegiance was recited.

ROLL CALL: Those present included Mr. Rick Saunders, Mr. Robert Jesteadt, Mr. Dale Kerr, Mr. Thomas Smith, and Mrs. Abbie Flinner.

TREASURER’S REPORT:

A motion was made by Mr. Saunders to approve the Treasurer’s report for March, 2022. Mr. Jesteadt seconded the motion. All in favor, motion carried.

ADMINISTRATIVE ACTION (Invoices): Motion made by Mr. Saunders to pay the bills. (General Fund: 14089-14113; Void: 14087,14088,14094); Payroll (3/31/22,4/14/22); (Electric-4/12/2022 -storage and main) Second by Mr. Jesteadt. All in favor. Motion carried.

A motion was made by Mr. Saunders and seconded by Mr. Jesteadt to approve the minutes for the March 16, 2022 meeting. All in favor. Motion carried.

CORRESPONDENCE:

Portersville Muddy Creek Township VFD Donation Letter – tabled from last meeting. Mr. Saunders made a motion to continue to contribute the funds collected through the fire tax, less a percentage of the expense of collection, as the annual donation to the Portersville Muddy Creek Township VFD. This was seconded by Mr. Jesteadt. All in favor. Motion carried.

ROAD DEPARTMENT REPORT:

Tires Needed for Township Vehicles – Mr. Saunders made a motion to order new tires for the township vehicles from Skander Tire, paying for this purchase with ARPA funds. Mr. Jesteadt seconded this motion. All in favor. Motion carried.

Pipe Purchase – Mr. Saunders made a motion to utilize ARPA funds to pay for the pipe supply purchased from Interstate Pipe and Supply. This was seconded by Mr. Jesteadt. All in favor. Motion carried.

Generator – New quotes were reviewed. Mr. Saunders made a motion to pursue the purchase and installation of a generator. Mr. Jesteadt seconded this motion. All in favor. Motion carried. A second motion was made by Mr. Saunders stating that, once a bid is accepted, this purchase is to be paid for utilizing ARPA funds. Mr. Jesteadt seconded this motion. All in favor. Motion carried.

SWM: Bear Run SWM Plan – Mr. Saunders made a motion to grant Bear Run Campground an extension for Phase #3 of their storm water management plan until December 1, 2022. Mr. Jesteadt seconded this motion. All in favor. Motion carried.

Brenneman Road – Mr. Saunders made a motion to send a letter to Portersville Borough, relinquishing any claim to the parcels located along Brenneman Road that lie fully within the boundaries of the Borough. Mr. Jesteadt seconded this motion. All in favor. Motion carried.

Grubbs – Hardship Exemption – Progress was reviewed. At this time, Mr. Grubbs has yet to have an inspection of the disconnection completed. Mr. Saunders made a motion to take formal action against Mr. Grubbs. This motion was seconded by Mr. Jesteadt. All in favor. Motion carried.

NEW BUSINESS:

137 Woody Wilson Hill Rd. – Mr. Saunders made a motion to comply with the Assessment Office/Mapping’s request to send a letter relinquishing any claim to this parcel (240-4F58-B2H-0000), as Mansion Law allows for the property owner to choose to be part of Lancaster Township and Seneca Valley School District. Mr. Jesteadt seconded this motion. All in favor. Motion carried.

Road project bids – Mr. Saunders made a motion that bid bonds be returned as performance/payment bonds have been received. Mr. Jesteadt seconded this motion. All in favor. Motion carried. Mr. Saunders also made a motion to release the bonds for the 2020 and 2021 oil projects. Mr. Jesteadt seconded this motion. All in favor. Motion carried.
