## ROAD DEPARTMENT REPORT:

- A. <u>Wallace Road (Gearhart) Driveway</u>. Drainage work not complete.
- B. <u>Bus/Car accident</u>: An accident on Stone Church Road between a bus and car.
- C. <u>Yellow Creek Road</u>: An accident which occurred on February 18, 2014 occurred in front of Mr. Ferson's property. He has requested approval to have boulders installed. Mr. Saunders stated that boulders cannot be placed in the township right of way.

- B. <u>Lowes Credit Line</u>: Increase to \$4,000. J. Reich provided a card. Old cards cancelled. A motion was made by Saunders and seconded by Mr. Jesteadt to approve the increase in credit limit. All in favor. Motion carried.
- C. <u>Address Numbering on Hufnagel</u>. There is an address sequencing error on Hufnagel Road. Mrs. Livermore will contact the property owners (Prengaman) to request the correction of their address so that the sequencing is correct.
