

# MUDDY CREEK TOWNSHIP BOARD OF SUPERVISORS November 18, 2020 1:00 PM

**CALL TO ORDER:** The Muddy Creek Township Board of Supervisors was called to order at 1:00 PM by Mr. Kerr. Pledge of Allegiance was recited.

**<u>ROLL CALL</u>**: Those present included Mr. Rick Saunders, Mr. Robert Jesteadt, Mr. Thomas Smith, and Mrs. Kelly Livermore was present. Mr. Dale Kerr was absent

**NOTICE OF RECORDING POLICY:** Mr. Saunders requested for anyone in the meeting to acknowledge the use of a recording device. No one acknowledged a recording device.

# PUBLIC COMMENT/VISITORS:

Keith Mikes – Sunset Ridge – Mr. Mikes has resubmitted a lot line revision plan. The SALDO requires that the developer submit a bond for the completion of the cul-de-sac.

Keith Wehr & Todd Wehr (Badger Hill Road): Mr. Wehr requested an extension on the submission of a stormwater management plan and land development plan as required by the cease-and-desist order issued.

A motion by Mr. Saunders and seconded by Mr. Jesteadt to the approve the extension request until May 19, 2021 for the submission of the stormwater management plan and land development plan. All in favor. Motion carried. As a condition of the extension approval, Mr. Wehr is required to submit a project timeline to the township by December 16, 2020.

Mr. Saunders made a motion to approve an agreement to complete a land development or subdivision plan by June 30, 2021 and authorize the occupancy of the mobile home if the septic for the home was tested and the certificate of occupancy was issued by the building code inspector. The motion was seconded by Mr. Jesteadt. All in favor. Motion carried.
